Raincity Athletics Inc. (the “Company”) COVID-19 Waiver

The “Raincity Athletics Inc. COVID-19 Waiver” works in tandem with the “Raincity Athletics Inc. Waiver”. Neither agreement limits or invalidates the other or any of their terms and conditions. In the event of conflict between the two agreements, the “Raincity Athletics Inc. Waiver” will take precedence.

ACKNOWLEDGE AND ASSUMPTION OF RISK

I understand that the novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, provincial, and local governments recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The Company has put in place preventative measures to reduce the spread of COVID-19; however, I understand that the Company cannot guarantee that I will not become infected with COVID-19. Further, my participation in any training or event hosted or sponsored by the Company could increase my risk of contracting COVID-19.

By signing this agreement, **I FREELY ACCEPT AND FULLY ACKNOWLEDGE** all such risks, dangers and hazards, resulting from my participation in any training or event hosted or sponsored by Raincity Athletics Inc.. I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending at a Company facility. and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at a Company facility may result from the actions, omissions, or negligence of myself and others, including, but not limited to the Company, its coaches, officials, members, agents, directors, officers, employees and representatives, and other participants.

RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND INDEMNITY AGREEMENT

I hereby agree as follows:

TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against Raincity Athletics Inc., its coaches, officials, members, agents, directors, officers, employees and representatives, and other participants (all of whom are hereinafter collectively referred to as “Releasees”) in connection with my participation in any training or event hosted or sponsored by the Company. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Releasees **RELATED TO COVID-19**, whether a COVID-19 infection occurs before, during, or after participation in any training or event hosted or sponsored by the Company.

I HAVE READ, understood and agree with the statements in the **ACKNOWLEDGEMENT AND ASSUMPTION OF RISK** portion of this document, and by assuming and acknowledging this risk, I completely absolve all **RELEASEES** from any and all liability **RELATED TO COVID-19**, including any loss, damage, injury or expense that I may suffer, that a third party may suffer, or that my next of kin may suffer as a result of my participation in any training or event hosted or sponsored by the Company.

I WARRANT that any representations I make about my health to the Releasees by any means, including without limitation by informing the Company I am in good health by completing the Company’s health self-assessment form(s) and following its self-assessment procedures, or other procedures, prior to appearing at a Company facility, are true and correct.

IN ENTERING INTO THIS AGREEMENT I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this agreement.

I HAVE READ AND UNDERSTOOD THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS OR ASSIGNS MAY HAVE AGAINST THE RELEASEE.
